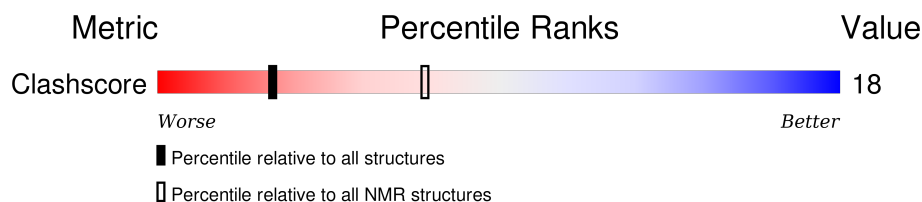
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

SOLUTION NMR



The overall completeness of chemical shifts assignment was not calculated.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$

- The chemical structure shows a bicyclic system consisting of a six-membered ring fused to a five-membered ring. The six-membered ring has two carbonyl groups (C5=O1 and C8=O2) and two amino groups (C7-N3 and C13-N2). The five-membered ring has a nitrogen atom (N2) and a side chain (C1-C2(R)-N1) where N1 is an ammonium group (NH3+). The atoms are labeled with green text: C1, C2(R), C3, C4, C5, C6, C7, C8, C9, C10, C11, C12, C13, O1, O2, N1, N2, N3. 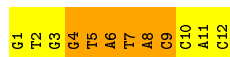

4 Residue-property plots

These plots are provided for all protein, RNA and DNA chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

5 Refinement protocol and experimental data overview

The models were refined using the following method: *distance geometry and molecular dynamics*.

Of the 12 calculated structures, 1 were deposited, based on the following criterion: *lowest number of NOE violations*.

A bond length (or angle) with $|Z| > 5$ is considered an outlier worth inspection. RMSZ is the (average) root-mean-square of all Z scores of the bond lengths (or angles).
